4.2 Most important symptoms and effects, both acute and delayed

Symptoms : Oil acne/folliculitis signs and symptoms may include formation of black pustules and spots on the skin of exposed areas. Ingestion may result in nausea, vomiting and/or diarrhoea.

Local necrosis is evidenced by delayed onset of pain and tissue damage a few hours following injection.

4.3 Indication of any immediate medical attention and special treatment needed

Treatment : Notes to doctor/physician:
Treat symptomatically.
High pressure injection injuries require prompt surgical intervention and possibly steroid therapy, to minimise tissue damage and loss of function.
Because entry wounds are small and do not reflect the seriousness of the underlying damage, surgical exploration to determine the extent of involvement may be necessary. Local anaesthetics or hot soaks should be avoided because they can contribute to swelling, vasospasm and ischaemia. Prompt surgical decompression, debridement and evacuation of foreign material should be performed under general anaesthesia, and wide exploration is essential.
